 Testosterone - Sustanon- 250 injection Restandol Testocaps Tostran gel 2% 	Interim RED see other information	Constitutional delay in growth and puberty and for hypogonadism in children and adolescents.	Traffic light status for all formulations of testosterone in this cohort is to be RED pending completion of shared care protocol. Following completion it was considered that Sustanon-250 Injection would be amber 1, whilst the Restandol® Testocaps and Tostran Gel 2% would become amber 1 or 2
VisuXL eye drops	GREY	Post surgery corneal ulcers / severe dry eye	Lack of evidence to support prescribing over other available products

Horizon Scanning, Formulary amendments and traffic light changes Horizon scanning - GREY classification assigned until formal submission Testavan20mg/g transdermal gel - GREY due to environmental impact of the device with no additional clinical benefit. Estriol 50micrograms/g vaginal gel, Blissel® for the local treatment of vaginal dryness in postmenopausal women with vaginal atrophy - GREEN Formulary amendments and traffic light changes: Linagliptin/metformin (Jentadueto 2.5/1000 and 2.5/850) added as GREEN for patients on a stable combination of linagliptin and metformin only. Pregabalin - Formulary updated - pregabalin can be prescribed in preference to gabapentin for neuropathic pain in palliative care patients. Salicylic acid 40% corn/ verruca removal plasters - GREY with a note for self care Clonidine 25mcg GREEN for postmenopausal symptoms Deodorant sprays removed from Stoma ancillaries formulary - GREY **Current work in development** ADHD shared care protocols Melatonin evidence and guideline review
